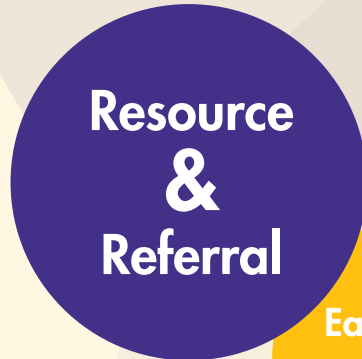

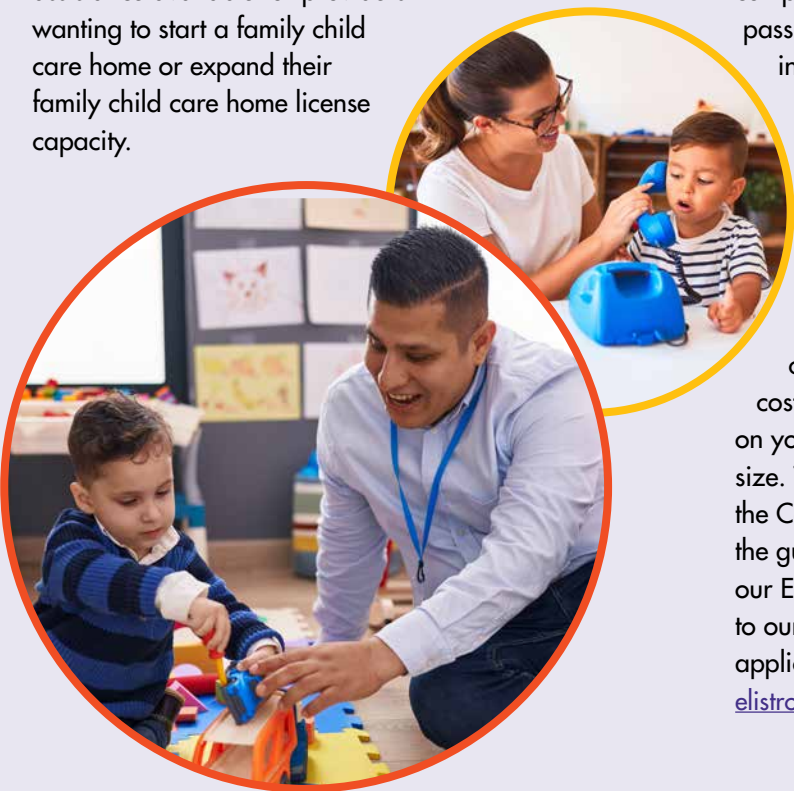


The Riverside County Office of Education (RCOE), Resource & Referral (R & R) program is a vital component of Early Care and Education (ECE). RCOE, Resource & Referral provides multiple services to families, early childhood education providers, and the community supporting quality early education services and fostering healthy development of all children. All services are provided at no charge to families and early childhood education providers and are available in English and Spanish.



### **Child Care Initiative Project (CCIP)**

The California Child Care Initiative Project (CCIP) strengthens child care for families. We recruit new home-based providers and support current providers with free training, resources, and community connections. Training and technical assistance available for providers wanting to start a family child care home or expand their family child care home license capacity.



### **Passport to Success (Training Pathways)**

RCOE, Resource & Referral offers training pathways for potential providers, family child care home providers, and child care center staff and administrators. Each training has accompanying digital resources and/or companion books. Completion of a strand in the passport pathway will result in an educational incentives package for the provider. ### **Child Care Eligibility List (EL)**

Families who need assistance with paying for child care services can apply to the child care Eligibility List (EL). Eligibility for cost-assisted (subsidized) child care is based on your gross (before taxes) income and family size. The California Department of Education and the California Department of Social Services set the guidelines for the selection of families from our EL. These families are selected according to our funding mandates. ### **Training, Technical Assistance, & Provider Supports**

Various provider supports, such as specialized training, program supplies, program technical assistance, and Communities of Practice, can be provided, if resources are available.
