- I/We have read the National History Day rules regarding student behavior and will conform to the rules.
- I/We understand that anyone who disturbs the judging process will be asked to leave.
- I/We understand that plagiarism is illegal. I/We understand that copyright use must be sought on all copyright materials. I/We understand that violation of these rules may result in disqualification of the entry.
- I/We understand that Riverside County Office of Education will not be responsible for loss or damage to projects and personal belongings. All projects/belongings not removed by the specified time will be discarded.
